As I drove my husband of 18 years to the emergency room last November, he apologized for the inconvenience. "I'm sorry," Dan said. "I just can't believe this is happening."

Dan had been struggling with sleeplessness, depression and anxiety for months. Persistent negative thoughts plagued him, until they crowded out everything else. He was suffering from the second epidemic that's raging throughout the world right now: the mental health crisis.

After several weeks of minimal sleep, Dan finally got an emergency telehealth appointment with a psychiatrist. After 10 minutes of talking with him, she had me join the Zoom call and told me I needed to take Dan to the nearest ER for a psychiatric evaluation immediately.

2023 Executive Council Nominations

We are now accepting nominations for the 2023 Executive Council. Positions up for nomination are President-Elect, Financial Officer, Region 1 Representative, and Region 3 Representative. Position descriptions and responsibilities are below:

The **President-Elect** shall take office on the first of January of the calendar year after having been elected at the annual meeting and shall serve for one year. During the term of office the President-Elect shall serve as assistant to the President, and shall succeed the President should that office be vacated before the full term is served, complete the unexpired term, and continue through the regular term of office. During the term of office, the President-Elect shall oversee strategic planning and the MPA election process for the Association.

The **Financial Officer** shall be a Member of the MPA who has been elected by the members at alternate even-year annual meetings. The Financial Officer shall take office on the first day of January of the calendar year after having been elected at the annual meeting and shall serve for two years. The Financial Officer shall oversee all MPA financial activities.

Regional Representatives shall be Members of the MPA who shall be elected from their respective geographical regions. The Term of office for the Regional Representatives shall be three years. Regional Representatives shall take office on the first day of January of the year following their election. Regional Representatives are limited to three-year terms of office, but can stand for election again after three years out of office. Elections shall be held in accordance with Article VIII with the exception that the nominees must reside in the region they represent and nominations and election for a region must come from the MPA Members of that region. The Regional Representatives shall represent MPA interests within their respective regions.
