## LETTER FROM THE PRESIDENT



David Gavel, Ph.D.

Not counting the first 18 years of your life, how many years of education did you complete to get where you are? Seven? Eight? Nine? How many hours of hands-on well-supervised training did you receive in graduate school, pre-doc internship, and post-doc training before you were deemed competent to provide a psychological service that directly or indirectly impacts the lives of consumers? Felt like a million, right? How many expensive, time-consuming, and intensive hours have you spent continuing your education to remain an expert in your field or maybe even develop new competencies and expertise in other fields?

So, let me ask you this: Was it all worth it? Is it all worth it?

The answer I hope you conclude is, "Yes, it was all worth it." I hope the investment that went into your profession has paid off in terms of job satisfaction, financial security, social mobility, trips to the golf course (insert your favorite anger inducing hobby), and any other measure of professional success that our career psychologist colleagues have developed. But I want to focus your attention on how your investment to become an expert in psychology is all

worth it because it situates you to fill roles in communities that others cannot fill with the same level of expertise. Research, training, consulting, marketing, educating, testing, leading, and even providing direct mental health services.

I know I'm not supposed to say that last one because there are number of other pathways to becoming a quality mental health provider. And I know there are a number of quality mental health providers that are not psychologists. Both of those things are true. And yet, it is also true that the nature, quality, and intensity of your training provides something that other disciplines do not have. So, what is my point?

The American Psychological Association is currently in the process of developing guidelines for the inevitable roll-out of APA accredited master's level psychology training programs. This initiative was a primary topic of the SPLC conference in D.C. a few weeks ago and I have to say that I left the conference with more questions and concerns about this initiative than I had when I arrived. This is not to say I am against the initiative. In fact, I think I am in favor of it. But my opinion is only one of the many among Mississippi psychologists. As individual psychologists, I would urge you to read through this, ask questions, and form opinions about this process. To get you started, I have included a link **HERE** to a published slide deck presented to us in D.C. As the leadership team for Mississippi Psychological Association, your Executive Council needs to know your thoughts on this issue and how to best represent our state. We seek to represent our membership and advocate for the issues you find important. Please feel to reach out to me or any other member of the EC with your thoughts, questions, and perspectives. Members can also post questions or comments to the MPA listserv and stimulate healthy dialogue. In whatever way makes you most comfortable, become informed and help inform others.

# MPA LEGISLATIVE COMMITTEE UPDATE

The Mississippi Psychological Association (MPA) Executive Committee commissioned the Legislative Committee to continue the work that began during the previous session in the 2024 Legislative Session. The Legislative Committee worked towards the enactment of an interstate compact for psychologists (PSYPACT), which is designed to facilitate the practice of telepsychology and the temporary in-person, face-to-face practice of psychology across state boundaries. The efforts were successful; the bill was signed into law on April 8, 2024, and it became effective immediately. The PSYPACT Commission is the governing body of PSYPACT responsible for oversight of the compact and for writing the Bylaws and Rules that govern PSYPACT. Each PSYPACT state has appointed a representative to serve as their state's Commissioner. Currently, 41 states are participating in PSYPACT.

PSYPACT addresses an increased demand to provide and receive psychological services via electronic means (telepsychology), and it increases the number of qualified licensed psychologists available to provide psychological services in areas where services are not available. One of the primary benefits of PSYPACT is continuity of care. With the population becoming increasingly mobile, there is an increased need for continuity of services across state lines. Most importantly, PSYPACT requires that psychologists from outside of the state be appropriately credentialed. PSYPACT provides protection to the public by certifying that psychologists have met acceptable standards of practice, and it provides compact states with a mechanism to address disciplinary issues that occur across state lines.

## WHAT IS PSYPACT

The Psychology Interjurisdictional Compact (PSYPACT®) is an interstate compact designed to facilitate the practice of telepsychology and the temporary in-person, face-to-face practice of psychology across state boundaries.

The PSYPACT Commission is the governing body of PSYPACT responsible for creating and finalizing the Bylaws and Rules and Regulations. The Commission is also responsible for granting psychologists the authority to practice telepsychology and temporary in-person, face-to-face practice of psychology across state boundaries.

Telepsychology In order to practice telepsychology in PSYPACT states, psychologists licensed in PSYPACT states only can apply to the PSYPACT Commission for an Authority to Practice Interjurisdictional Telepsychology (APIT™). One required component of this authority granted from the PSYPACT Commission is that psychologists must obtain an E.Passport Certificate from ASPPB. Temporary Practice In order to conduct temporary practice in PSYPACT states, psychologists licensed in PSYPACT states only can apply to the PSYPACT Commission for a Temporary Authorization to Practice (TAP™). One required component of this authorization granted from the PSYPACT Commission is that psychologists must apply for and obtain an Interjurisdictional Practice Certificate (IPC) from ASPPB. \*Providers are responsible for maintaining knowledge of and complying with each PSYPACT State's laws, rules, and regulations - for each PSYPACT state the provider is practicing into or out of.\*

#### **PSYPACT Commission Requirements**

In order to practice telepsychology under the authority of PSYPACT, the PSYPACT Commission requires that a psychologist obtain an Authority to Practice Interjurisdictional Telepsychology (APIT).



#### **Authority to Practice Telepsychology Requirements**

- Hold an E. Passport issued by ASPPB. More information including eligibility requirements, and how to apply can be found at https://www.asppb.net/page/telepsychology
- You must hold a full, unrestricted license to practice psychology based off a doctoral level degree in at least ONE PSYPACT participating state/jurisdiction.
- Have no history of disciplinary action listed on any psychology license.
- · Provide attestations

#### **PSYPACT Fees:**

APIT Application Fee: \$40APIT Annual Renewal Fee \$20

## **Y** Scope of Practice

Subject to the Receiving State's scope of practice



**Initiation and Provision of Psychological Services** 

When using the APIT to provide telepsychology services into a Receiving State, the psychologist must physically be located in the psychologist's PSYPACT declared "home state".



#### To Conduct TEMPORARY PRACTICE

TAP only pertains to in person, face-to-face practice.



#### **PSYPACT Commission Requirements**

 In order to conduct temporary practice under the authority of PSYPACT, the PSYPACT Commission requires that a psychologist obtain a Temporary Authorization to Practice (TAP).



## **Temporary Authorization to Practice Requirements**

- Hold an Interjurisdictional Practice Certificate (IPC) issued by ASPPB. For information regarding obtaining an IPC please visit https://www.asppb.net/page/temporarypractice
- You must hold a full, unrestricted license to practice psychology based off a doctoral level degree in at least ONE PSYPACT participating state/jurisdiction.
- Have no history of disciplinary action listed on any psychology license.
- Provide attestations



#### Fees

#### **ASPPB Fees:**

IPC Application Fee: \$200IPC Annual Renewal Fee: \$50

#### **PSYPACT Fees:**

- TAP Application Fee: \$40
- TAP Annual Renewal Fee \$20



#### **Time Limit**

• 30 days per calendar year per PSYPACT state



#### Scope of Practice

Subject to the Distant State's scope of practice



#### **Authority and Law**

When using the TAP to provide services into a Distant State the psychologist will be subject to the Distant State's authority and law.



# APA calls for prohibiting punitive isolation of youths in juvenile justice settings

#### March 6, 2024

WASHINGTON — The American Psychological Association has called for prohibiting the placement of youths in isolation in juvenile justice settings, except for emergencies, citing the research showing its detrimental effects on mental health and development.

"APA stands firm in its opposition to the isolation of youth in juvenile justice settings," said APA President Cynthia de las Fuentes, PhD. "Solitary confinement can have profound and lasting effects on the psychological well-being of young individuals, and it is imperative that we advocate for alternative approaches that prioritize rehabilitation and support."

APA's governing Council of Representatives adopted a resolution calling for the prohibition at its meeting Feb. 23. The measure passed by a vote of 154-2, with one abstention.

The resolution, titled "APA Resolution Opposing Isolation of Youth in Juvenile Justice Settings," marks a milestone in APA's ongoing commitment to advocating for the well-being and rights of youth involved in the juvenile justice system.

# APA adopts groundbreaking policy supporting transgender, gender diverse, nonbinary individuals

#### February 28, 2024

WASHINGTON — The American Psychological Association has adopted a landmark policy affirming evidence-based care for <u>transgender, gender diverse and nonbinary</u> children, adolescents and adults, noting that recent legislative attempts to obstruct access to psychological and medical interventions for such individuals puts them at risk of depression, anxiety and other negative mental health outcomes.

"The adoption of this resolution reaffirms APA's dedication to promoting inclusivity, dignity and access to quality health care for all individuals, regardless of their gender identity or expression," said APA President Cynthia de las Fuentes, PhD. "It sends a clear message that state bans on gender-affirming care disregard the comprehensive body of medical and psychological research supporting the positive impact of such treatments in alleviating psychological distress and improving overall well-being for transgender, gender diverse and nonbinary individuals throughout their lives."

The policy, titled "Policy Statement on Affirming Evidence-Based Inclusive Care for Transgender, Gender Diverse, and Nonbinary Individuals, Addressing Misinformation, and the Role of Psychological Practice and Science," was approved by APA's governing Council of Representatives at its meeting on Feb. 24. The vote was 153-9 with one abstention.

The resolution also calls for insurance plans to extend coverage for health care services tailored to the developmental needs of children, adolescents, and adults identifying as transgender, gender diverse or nonbinary, encompassing both psychological and medical gender-affirming care.

"We believe that access to evidence-based health care is a fundamental right for everyone, and this policy reflects our commitment to promoting social justice and equity in health care," said de las Fuentes. "APA also affirms the essential role and legal rights of parents and caregivers to ensure the well-being of children and adolescents while honoring their expressed gender identity, including being involved in health care decision-making, and supporting developmentally appropriate youth self-advocacy."
